Re: Freedom of Information Act application

In reference to your application made pursuant to the *Freedom of Information Act 1991* (FOI Act), access was sought to:

On 25 October 2022, South Australia Police (SAPOL) advised you that the scope of these parts of your request was considered an unreasonable diversion of the agencies resources. On the same day you responded via email and narrowed the scope of your request to;

"d) The document that grants the SA Police Commissioner authority to direct a wo/man to wear a mask for a medical reason e) Any single document that evidences SA Police received a study that proves masks stop the spread of COVID19, before the SA Police Commissioner enforced mask wearing

Time range for d & e documents is a period of between June 2019 and Oct 2022."

In relation to these parts of your request:

"a) All documents that evidence personal incentives, financial gains, or any other reward-based programs that may motivate an SA Police Officer to issue an Explation Notice. b) All documents that evidence SA Police Officers may be required to meet
