## Re: Freedom of Information Act application

In reference to your application made pursuant to the *Freedom of Information Act 1991* (FOI Act), access was sought to:

"1. Statistics re lost or stolen police equipment including electronic equipment, police vehicles, firearms, weapons, ammunition, identification (such as badges), capsicum spray, clothing (ie. Bulletproof vests, equipment belts), handcuffs, and batons.). 2. NSW Police reports including AV material such as footage relating to the theft/damage of either police vehicles or firearms. Please proceed on this basis. Timeframe: From 1 January 2023 to the date this application is validated.

On 27 August 2024 you further clarified your request as follows:

"Please note there's a typo here. Please substitute NSW to SA."

## In relation to part 1 of your request

*"1. Statistics re lost or stolen police equipment including electronic equipment, police vehicles, firearms, weapons, ammunition, identification (such as badges), capsicum spray, clothing (ie. Bulletproof vests, equipment belts), handcuffs, and batons.)".* 

All SAPOL equipment that is lost or stolen should have a Property Damage, Loss, or Stolen Report (PD98) completed. Once processed, these reports are stored in the Total Records Information Management (TRIM) system. The TRIM search function relies on keywords, specifically those entered in the container or document title field, such as PD98. This search function cannot locate documents outside of these keyword searches.

Although SAPOL records and stores this data within its systems, keyword searches may not reliably and comprehensively retrieve all relevant data for your request given the data is manually entered and reliant on the word 'PD98' being included in the metadata.





Similarly, the SHIELD crime and incident reporting system is unable to be reliably interrogated as the results are dependent on the many different variables available when entering data.

Despite efforts to find ways to provide the requested information, the data is not readily available, and our systems cannot produce a document that meets your requirements.

## In relation to part 2 of your request

*"2. NSW Police reports including AV material such as footage relating to the theft/damage of either police vehicles or firearms. Please proceed on this basis. Timeframe: From 1 January 2023 to the date this application is validated".* 

On 24 September 2024 you further clarified that you required documents relating to malicious damage within South Australia only.

South Australia Police (SAPOL) has located documents that fall within the scope of your request. The documents are numbered and described in the following schedule. The schedule contains the details of the determination in compliance with section 23.

## CLAUSES FOR REFUSAL

Clause 4(1)(b) of Schedule 1 of the FOI Act which states:

"A document is an exempt document if it contains matter the disclosure of which could reasonably be expected to prejudice the fair trial of any person or the impartial adjudication of any case"

Clause 4(2)(a)(iii) of Schedule 1 of the FOI Act which states:

"A document is an exempt document if it contains matter the disclosure of which could reasonably be expected to prejudice the effectiveness of any lawful method or procedure for preventing, detecting, investigating or dealing with any contravention or possible contravention of the law (including any revenue law)."

Clause 4(2)(b) of Schedule 1 of the FOI Act states: "A document is an exempt document if it contains matter the disclosure of which would, on balance, be contrary to the public interest."

Clause 6(1) of Schedule 1 of the FOI Act which states: "A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead)."

Please note; enquiries were made with firearms branch and the police armory who provided the information that there are no reports relating to the theft/damage of SAPOL firearms during the period of your request.

If you are dissatisfied with this determination, you are entitled to exercise your right of internal review in accordance with section 29(1) of the FOI Act by completing a PD362 Application for Internal Review form, which can be downloaded from <a href="https://www.police.sa.gov.au/services-and-events/freedom-of-information">https://www.police.sa.gov.au/services-and-events/freedom-of-information</a> or available upon request at your nearest police station. Alternatively, an application may be made in writing to the SAPOL Freedom of Information Unit. This application must be lodged within 30 (calendar) days after you receive this letter with a fee of \$42.00, if applicable.
