Summary: At about 1845hrs on 13/04/2022 at Beach Road, CHRISTIES BEACH, suspect ⁶⁽¹⁾ was in possession of a large sword waving it at traffic. Police attended and located ⁶⁽¹⁾ who removed a sword from his pants. Police directed ⁶⁽¹⁾ to drop the sword and after a short period of time he complied. Suspect was arrested and placed in rear of police cage S303-BQA (385) when he headbutted the front perplex causing the external glass to crack. Witnesses / CCTV footage available.

⁶⁽¹⁾ was handcuffed to rear and watched by [PETERSEN, TRISHA](#) through CCTV and seen to headbutt the front perplex of the cage causing the outside glass to crack approximate damage \$500.

Occurred at about 1845 hrs on Wednesday the 13th April 2022 - Cage was parked on footpath of Beach Road just East of the South Bound entrance to Southern Expressway at HACKHAM WEST.
