## Re: Freedom of Information Act application

In reference to your application made pursuant to the *Freedom of Information Act 1991* (FOI Act), access was sought to:

"1. How many operations involving the use of handheld scanners (wands) have been conducted across South Australia by SAPOL? 2. How many individuals have been subjected to the use of handheld scanners across South Australia? (i.e. How many individual instances of handheld scanners being used?) 3. How many knives (or other edged weapons) have been detected as a result of handheld scanning across South Australia?" Date range: 1/7/2023 to 30/6/2024

On 23 October 2024, as a result of a discussion with your office, it was confirmed that '*handheld scanners* (*wands*)' refers to handheld metal detectors.

## In relation to part 1 of your request:

*"1. How many operations involving the use of handheld scanners (wands) have been conducted across South Australia by SAPOL?"* 

South Australia Police (SAPOL) has interpreted your request for '*number of operations*' as '*number of declarations*' as SAPOL record the number of events in which metal detectors are used by way of a declaration pursuant to Section 72A (4) of the Summary Offences Act and not per '*operation*'.

SAPOL has located information that falls within the scope of your request, and it is agreed to *release this information to you in full*.
