#### Hi Andy

We're just looking at the two attached FOI documents and the calculation of average time delayed. The calculations we assume have been used are accurate for the figures in the 'callout 2' document (the calculation being: total delay time divided by the total delay incidents, then converting to an hourly figure).

However, the figure for 2023-24 (in the 'callout 1' document attached) on our calculation is 1430 (total delay time) divided by 629 (total delay incidents) = 2.27. This figure converted to an hourly figure = 2.16 hours, not 2.33 hours as stated.

Can you please, as a matter of urgency, confirm that figure for us? And if 2.33 hours is incorrect, can the FOI please be revised and re-issued?
