Police KIDD phoned PSSB call centre in relation to obtaining a copy of the CCTV footage of the incident. They advised Police that they would need to attend PHQ and speak with staff in relation to getting a copy of the footage.

KIDD attended and spoke with staff at PHQ who advised that were under the impression the occ was finalised and there were no further enquiries. KIDD advised it was still a current open investigation and that further follow ups were required. PSSB staff stated they could not provide a copy of the CCTV but still had still images of the suspect.

One PSSB statement currently attached. PSSB staff stated they could not provide details about how much damage was caused and didnt have details of who would be fixing this damage and may need to be followed up later on.

I have uploaded photographs of the damage and photogrpahs of the suspect matching the his recent shield custody photo. Will likely need a statement from which ever member identified the suspect which again could not be provided by PSSB staff.

I have flagged the suspect as wanted as there is enough information to go off based on suspect images and PSSB witness statement.
