**Summary:** <sup>6(1)</sup> [redacted] arrested at the scene. Whilst being conveyed to CBPS she has kicked the left passenger window causing it to smash.

At about 0040 hrs 19/06/2022 the victim <sup>6(1)</sup> [redacted] was assaulted by <sup>6(1)</sup> [redacted] b punching to his head with a clenched fist and kicking him.

Upon arrival of Police ELDRIDGE/POTTER <sup>6(1)</sup> [redacted] was arrested and placed in the rear of the Police vehicle, <sup>6(1)</sup> [redacted] was extremely agitated and abusive towards Police.

Whilst being conveyed to CBPS, <sup>6(1)</sup> [redacted] required to be continually restrained by Police and using her left leg she kicked the left rear passenger window on Police Fleet SA Reg S926BQB fleet number 345, causing the window to smash and glass to fall into the vvehicle as well as a outward dent.
