Quotes attributable to Chief Psychiatrist, Dr John Brayley

SAPOL data shows a reduction in the number of occasions that handover between police and hospitals has exceeded the benchmark of 30 minutes, and a reduction in the percentage of transfers where a delay has occurred.

At the same time, there has been an increase in the number of police conveyances to hospital which reflects a large range of factors, however a possible contributor is an increase in presentations relating to substance use.

Significant collaboration between emergency services has helped in the development of strategies to avoid or reduce delays and improve handovers. This includes providing assessment in the community through the jo SAPOL Mental Health Co-response service and a similar co-response program with ambulance. Changes made to EDs are also helping to expedite assessments made by mental health teams.	int

They show SAPOL FOI mental health taskings.

It shows that total time delayed in ED after police have conveyed a person to hospital has reached its highest levels in six years last financial year at 1430 hours (based on the FOI data).

The number of conveyances has also hit the highest number at 2566 hours.

Hours have almost tripled in six years.

The Opposition's Jack Batty has supplied the following comments:

As if over 120,000 hours of ambulance ramping wasn t enough, the Malinauskas Labor Government is now presiding over thousands of hours of police car ramping.

We ve got our police losing thousands of hours on the ramp at a time when we have a massive shortfall in police numbers and skyrocketing crime.

Every hour that police spend waiting around on hospital ramps is an hour they are not out on the beat keeping us safe.

We ve now got police cars seemingly acting as make-shift ambulances in another debacle for the Malinauskas Labor Government.

We are constantly asking our police to do so much more with so much less and it is starting to impact frontline policing and community safety.
