On the 19 April 2024, one of my staff contacted you via telephone seeking clarification on the scope of your request. You amended the request to the below:

1.1 The number of road users issued with an expiation notice for the expiable traffic offence 'Turn right at intersection or other place with no right turn sign' (Offence Code A063) at the aforementioned location.

1.2 The number of road users issued with a caution for the expiable traffic offence 'Turn right at intersection or other place with no right turn sign' (Offence Code A063) at the aforementioned location.

1.3 The number of expiation notices that were initially issued but subsequently withdrawn (for any reason) for the expiable traffic offence 'Turn right at intersection or other place with no right turn sign' (Offence Code A063) at the aforementioned location.

2. For the day of Friday 15 March 2024, from the time of 7.00 am to 9.00 am (inclusive):
