Summary: ⁶⁽¹⁾ S.56 to RAH - Arrested for unlawfully on premises, climbed scaffolding on PHQ and threw scaffolding off from the top towards police.

At about 8.30 pm on Saturday the 16th of December 2023, ⁶⁽¹⁾, climbed the scaffolding in a protected area, attached to critical infrastructure namely the [Police Headquarters located at 100 Angas Street, ADELAIDE](#). Police were tasked to attend this location where cordons were set up, negotiations begun with the accused and a forward command was set up.

During the night the accused threw multiple scaffolding infrastructures off of where she was situated into Angas Street narrowly avoiding police.

At approximately 7.45 am on Sunday the 17th of December 2023, the accused, with the assistance of Negotiators, STAR force police officers, Metropolitan Fire Service, South Australian Ambulance Service and Special Operations was removed from the scaffolding attached to the Police Headquarters.

Police WALSH/HARVEY provided a safety escort to the Royal Adelaide Hospital with SAAS where paramedics and hospital staff placed her on a Mental Health Section.

At approximately 9.00 am police WALSH arrested the accused for unlawfully on premises of the Police Headquarters and for hindering and obstructing a Protective Security Officer in the course of their duty.

The accused was identified by photographic image on police systems (SHIELD)

The accused was advised she was under arrest on Police Body Worn Video while in the Royal Adelaide Hospital Room West 9.
